1. Lessee acknowledges receipt of cart and equipment in good working order conditional on initial inspections by Lessee. Lessee further acknowledges that the equipment is leased by Lessor or Lessee for the purpose it was manufactured (Subject, however, to the terms and conditions set forth herein). **Lessee acknowledges \$40.00 NON-REFUNDABLE deposit for reservation.**

2. Lessee/and or Driver shall indemnify and hold Affordable Golf Cart Rentals and Storage of NMB, LLC and affiliates harmless from any and all liability, including bodily injury and property damage, arising out of the use or operation of the equipment.

3. Lessee shall reimburse Affordable Golf Cart Rentals and Storage of NMB, LLC, upon demand for the loss or damage to the equipment while it is rented to Lessee and for all costs and expenses, including lost revenue from golf cart that would have been generated and all reasonable attorney fees, incurred by lessor in collecting any amounts owing by Lessee hereunder or in otherwise enforcing lessor's rights hereunder. Approximate value of each Golf Cart is \$2500.00. Each Cargo Caddie is \$90.00 (initial _____)

5. Lessee/Driver will abide by all the rules and regulations of Affordable Golf Cart governing the use of equipment and all laws of South Carolina and the following rules:

A. Driver allowed on Secondary roads only (May cross primary roads only)

B. Driver agrees to abide by all traffic laws

C. Lessee agrees all drivers must have a valid driver's license

D. Driver to operate during daylight hours only.

E. Driver agrees to not drive recklessly.

F. Driver agrees to not drive on beach

(Violations will result in loss of cart privileges without refund)

6. I understand that any driver of a golf cart in North Myrtle Beach, SC must be at least 16 years old with a valid driver's license. I understand that the North Myrtle Beach Police will impound the golf cart for violations, and I will be responsible for paying all fines and fees plus \$75.00 for retrieval. I understand that I am responsible for any damages to the vehicle while in my possession. In this event, I authorize Affordable Golf Cart to bill my credit card for repair and/or replacement. It is mutually understood that this is a transaction in Horry County, in the State of South Carolina. Any and all disputes, action at law, suit in equity or judicial proceedings for the enforcement of this agreement or its provisions, shall be instituted in Horry County, South Carolina. I further agree to be responsible for and pay for any and all collection fees and attorney's fees.
